IMPORTANT DECISIONS OF THE MANAGING COMMITTEE REGARDING CLUB MEMBERSHIP W.E.F. 01 JUL 2019

1. General

We wish to highlight that our concern for members and their dependants, as also all round improvements in the Club, remain paramount. This is evidenced by the decisions of the Managing Committee enumerated in the succeeding paragraphs.

2. Associate Dependant Membership (ADM) Scheme - II

Based on suggestions of members, we have approved re-commencement of ADM scheme- II for 100 dependants on first-cum-first served basis, as per following terms and conditions:-

- (a) **Commencement of Scheme.** Commenced on 01 July 2019 on first-cum-first-served basis and shall close on 31 Dec 2019.
- (b) **Eligibility.** Two dependant children of Founder, Life, Permanent and Associate Members shall be permitted to become members under the scheme. Dependant children of members enrolled under concessional scheme for Senior Citizens shall not be eligible.
- (c) **Non-refundable membership entry fee.** Dependants shall pay an amount of Rs. 75,000/- plus GST toward non-refundable Membership Entry Fee.
- (d) Age. Between 21 and 35 years.
- (e) Interview. Eligible candidates shall be interviewed by Membership Sub-committee.
- (f) **Payment of Subscription.** On becoming member, ADMs shall pay monthly subscription/other charges plus GST from date of grant of membership.
- (g) **Transfer of Membership.** Shall not be permitted except on demise of member to spouse only. Parents of ADMs shall not be allowed to seek dependant membership.
- (h) Voting Rights. Shall have no voting rights.
- (j) **Termination of membership.** As applicable to all catergory of members.

3. Transfer of Membership from Brother to Sister and Sister to Brother.

Transfer of membership among siblings has been allowed as per following terms and conditions: -

- (a) Shall pay Rs. 75,000/- plus GST toward non-refundable transfer charges.
- (b) Transfer shall be allowed only once (FM to PM, LM to LM, PM to PM and AM to AM and transferee/new member shall be required to pay subscription|-other charges plus GST.
- (c) Shall have voting rights except Associate Members.

- 4. **Founder Membership (FM) to Legal Heir without any charges.** Since majority of Founder Members (FMs) have advanced in age and are reportedly not making use of Club facilities, we have decided to allow transfer of membership to legal heir without any charges (free of cost) as per following terms and conditions: -
 - (a) Founder Membership (FM) shall be transferred as Permanent Membership (PM) without any charges to legal heir i.e. spouse, son, daughter and grand child, all above 21 years..
 - (b) On transfer, the new member shall pay subscription/other charges plus GST as applicable to Permanent Members.
 - (c) Shall have voting rights.
- 5. **Transfer of Membership to Blood Relations.** Besides above two issues covered in Para 3 and 4 above, the other cases of transfer of membership shall be allowed as per following terms and conditions:-
 - (a) Permitted to direct blood relation only once and such transfer shall be to father, mother and spouse as also to son, daughter and grand child (all 21 years and above) on production of proper documents.
 - (b) Required to pay one time non-refundable transfer charges of Rs. 50,000/- plus GST.
 - (c) Membership shall be transferred from LM to LM, PM to PM and AM to AM.
- 6. **Transfer on Demise of Member.** There is no change in the current policy on transfer of Membership in event of unfortunate demise of a member. The membership shall be transferred without any charges to spouse or a nominee of spouse (son, daughter and grand child), as per rules.

7. Concessions granted to Outstation Members

- (a) Outstation members, both outside and inside the Country, shall pay 50% of applicable subscription plus GST.
- (b) If a member is a senior citizen availing 25% concession on payment of subscription and granted outstation membership, he/she shall get only one concession i.e. maximum 50% exemption on payment of subscription plus GST.

8. Incentive to Promote Associate Membership

We have decided to offer Associate Membership (AM) in interest free instalments spread over a period of one year. We sincerely hope that response from prospects is likely to be encouraging.
